### Release and Waiver of Liability and Indemnity Agreement

(Read Carefully Before Signing)

In consideration of being permitted to participate in any way in the Dance Program indicated below and/or being permitted to enter for any purpose any restricted area (here in defined as any area where in admittance to the general public is prohibited), the parent(s) and/or legal guardian(s) of the minor participant named below agree:

- 1. The parent(s) and/or legal guardian(s) will instruct the minor participant that prior to participating in the below dance activity or event, he or she should inspect the facilities and equipment to be used, and if he or she believes anything is unsafe, the participant should immediately advise the officials of such condition and refuse to participate. I understand and agreed that, if at any time, I feel anything to be UNSAFE, I will immediately take all precautions to avoid the unsafe area and REFUSE TO PARTICIPATE further.
- 2. I/WE fully understand and acknowledge that:
  - (a) There are risks and dangers associated with participation in Dance events and activities which could result in bodily injury partial and/or total disability, paralysis and death.
  - (b) The social and economic losses and/or damages, which could result from these risks and dangers described above, could be severe.
  - (c) These risks and dangers may be caused by the action, inaction or negligence of the participant or the action, inaction or negligence of others, including, but not limited to, the Releasees named below.
  - (d) There may be other risks not known to us or are not reasonably foreseeable at his time.
- 3. I/WE accept and assume such risks and responsibility for the losses and/or damages following such injury, disability, paralysis or death, however caused and whether caused in whole or in part by the negligence of the Releasees named below.
- 4. I/WE HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the dance facility used by the participant, including its owners, managers, promoters, lessees of premises used to conduct the dance event or program, premises and event inspectors, underwriters, consultants and others who give recommendations, directions, or instructions to engage in risk evaluation or loss control activities regarding the dance facility or events held at such facility and each of them, their directors, officers, agents, employees, all for the purposes herein referred to as "Releasee"...FROM ALL LIABILITY TO THE UNDERSIGNED, my/our personal representatives, assigns, executors, heirs and next to kin FOR ANY AND ALL CLAIMS, DEMANDS, LOSSES OR DAMAGES AND ANY CLAIMS OR DEMANDS THEREFORE ON ACCOUNT OF ANY INJURY, INCLUDING BUT NOT LIMITED TO THE DEATH OF THE PARTICIPANT OR DAMAGE TO PROPERTY, ARISING OUT OF OR RELATING TO THE EVENT(S) CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE RELEASEE OR OTHERWISE.
- 5. I/WE HEREBY acknowledge that THE ACTIVITIES OF THE EVENT(S) ARE VERY DANGEROUS and involve the risk of serious injury and/or death and/or property damage. Each of THE UNDERSIGNED also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.
- **6.** EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the Province or State in which the event is conducted and that if any portion is held invalid, it is agreed that the balance shall, notwithstanding continue in full legal force and effect.
- 7. On behalf of the participant and individually, the undersigned partner(s) and/or legal guardian(s) for the minor participant executes this Waiver and Release. If, despite this release, the participant makes a claim against any of the Releasees, the parent(s) and/or legal guardian(s) will reimburse the Releasee for any money which they have paid to the participant, or on his behalf, and hold them harmless.

# Studio Policies /Regulations Class Placement

- The School Director will determine class placement and her decision will be final.
- Classes may be cancelled if the class enrollment falls below five students.
- Classes may be added if at least five students show interest in a specific class
- Class size will be limited to approximately 14 students, depending on the type of class.

#### **Newsletters**

- Newsletters will be e-mailed at the beginning of every month.
- The newsletters will inform you of class closings due to holidays, parents' observation days, and any other special information.
- Unless otherwise informed we are open for classes. Tuition remains the same every month regardless of holidays or closings.

#### **Tuition**

 There will be a registration fee of \$30.00 per individual, and \$15 for each additional sibling. (max registration fee \$60) There will also be a yearly fee of \$15 per aerial silks student to cover additional liability insurance now required for Aerial silks programs.

#### Tuition is based on a yearly rate and divided into 10 monthly payments.

- Tuition is due the <u>1st of every month</u>, August through May. Tuition paid after the <u>10th of the month</u> will automatically have a \$15.00 late fee.
- Tuition remains the same regardless of the number of weeks in the month or holidays.
- Tuition is non-refundable and non-transferable even if you or your child does not complete the month. Your child may "make-up" a missed class in another class.
- Tuition will be prorated for NEW STUDENTS only after the beginning of the month. To keep costs to a minimum we do not send monthly bills or statements!

### There are several payment options:

Automatic payments can be made from your bank account

- You can bring cash/check to the studio or pay using our "Square" option at the studio.
- You can pay through your parent portal.
- NOTE: There will be a \$25.00 service charge for all returned checks.

### Monthly Tuition is as follows:

- 1 Class per week \$68.00 (\$17.00 per class)
- 2 Classes per week \$128.00 (\$16.00 per class)
- 3 Classes per week \$180.00 (\$15.00 per class)
- 4 Classes per week \$224.00 (\$14.00 per class)
- 5 Classes per week \$250.00 (\$12.50 per class)
- 6 Classes per week \$276.00 (\$11.50 per class)
- 7 Classes per week \$308.00 (\$11.00 per class)
- 8 Classes per week \$320.00 (\$10.00 per class)
- 9 Classes or more per week \$342.00 (\$9.50 per class)

#### Parent Observation days:

- Parents/family will be allowed to observe class approximately every 10 to 12 weeks
- Notices will be sent home two weeks prior to the observation day.

#### **CLASS ATTIRE:**

## Combination Classes Ages 3, 4, and 5

 Any color leotard and tights will be acceptable. The correct dance shoe will be needed.

#### **Ballet:**

- All one-hour ballet classes will wear black leotards, pink tights, pink leather (not canvas) ballet shoes and hair in a bun for the girls.
- White t-shirts, black shorts/pants and white socks with black ballet shoes for the boys.

#### Jazz and Musical Theatre:

 Any type of leotard and tights or dance attire may be worn. NO STREET CLOTHES! The type of shoe will depend upon the teacher and level... tan slip on, black slip on, or black tie up jazz shoes will be decided by the teacher.

### Hip Hop

• Any type of <u>leotard</u>, <u>tights</u>, <u>accessories that can be danced in</u> may be worn. Dancers under the age of 10 taking a hip-hop combination class must have jazz/hip hop shoes that lace! One-hour hip hop classes may be required to have hip hop sneakers or Combat boots, please check with us before purchasing shoes.

# Tumbling/Contemporary/Lyrical/Modern:

 Any type of leotard and tights or dance attire may be worn. No street clothes, no T-shirts). Lyrical shoes or barefoot. If taking a dance combination class that includes tumbling, convertible tights will be necessary.

#### Tap:

 Any type of leotard and tights or dance attire may be worn. NO STREET CLOTHES! Blacks tap shoes. Single ribbon tie for all beginning/intermediate classes... More advanced and older girls/boys may be required to wear jazz taps or Mary Jane Taps. Please check with us before you purchase shoes.

#### Aerial Silks:

Leotard and tights. (can wear leggings over tights). with no embellishments or zippers of any type (no rhinestones, jewels or studs as these snag on the silks. No Jewelry. Hair must be up.

#### All Boys Classes:

· Shorts, shirt, socks, hip hop sneakers.

#### Hair:

 Hair must be worn up for all types of dance classes. Hair must be worn in a ballet bun for all one-hour ballet classes.

NOTE: Jewelry should not be worn in any dance class for safety concerns.

#### **General Class Information:**

- Students are expected to attend every class. The progress of the child and the class depends upon regular attendance.
- Classes will begin and end promptly at the scheduled time. Be dressed with shoes on before the scheduled start time. If your child is consistently late to a class you will be asked to move her/him to another class.
- If you anticipate being late, your child will be kept safely in our dance lobby. If for any reason someone other than yourself will be picking your child up, please notify the Ready, Set, Dance staff.
- NO GUM, CANDY, FOOD OR DRINKS ARE ALLOWED IN THE STUDIO.
   WATER IN A SPILL PROOF CONTAINER MAY BE BROUGHT INTO THE STUDIO.
- In the event of severe weather, dance class cancellations may occur and will not be made up. We try to be consistent with the Orange County Public Schools schedule, and if they close due to bad weather, we will close as well. If possible, a voice message will be left on our studio phone. (407-470-7365) and a message will be posted on our studio Facebook page.
- If your child misses a class, he/she is entitled to a "make-up" class. The make-up class must be made within one month of the absence and approved by either the teacher or Miss Tonya. Tuition remains the same, even if you choose not to make up the class.

#### Recital 2023

- Ready, Set, Dance will have an end of the year recital. Possible dates are June 2,3,4<sup>th</sup> at Olympia High School and the recital costs will be kept to a minimum. Recital is held over two or three days. Depending on age, level, or class, dancers may participate on one or both days! Tickets will be sold to offset the expense of the recital. All attending must purchase a ticket. (Recital Tickets were \$24.00 in 2022)
- A costume deposit of \$50.00 will be due by mid-December, with the balance due by February. Costume costs will be kept to a minimum! (Approx. \$70.00 for children and Approx. \$85.00 for adult sizes) Your child will need a costume for each dance class they are enrolled in. The costumes will come with the necessary tights.
